

The Melbourne Market is offering Fruit and Vegetable stand holders, Flower Market stand holders and Warehouse 5,6 and 7 tenants onsite mailboxes including mail delivery to mailboxes. Warehouses under ESR may also apply for mail delivery.

Stand holder mailboxes will be located within the fruit and vegetable trading floor close to the Customer Service Office (Cashiers Office). The mailboxes for warehouse 5,6 and 7 tenants are located close to the warehouse area. ESR warehouse tenants are required to supply their own mailbox outside their tenancy.

Melbourne Market mailboxes offer a safe and convenient location to have business mail delivered.
