

SUPER SATURDAYS MELBOURNE MARKET CONDITIONS OF ENTRY

THESE CONDITIONS OF ENTRY ARE IMPORTANT – PLEASE READ THEM

To provide an enjoyable and safe environment for all customers and visitors of the Melbourne Market (**the Market**), the Melbourne Market Authority ABN 56 160 141 887 (**MMA**) has adopted the following Conditions of Entry (**Conditions**):

1. Every person who enters the Market agrees to be bound by these Conditions. If anyone does not agree with any of the Conditions, they should immediately leave the Market by a designated exit.
2. Parents and guardians must supervise children at all times.
3. Bag checks may be conducted as a condition of entry.
4. All persons must follow any direction given by the MMA or authorised security personnel, including in relation to traffic management and in an emergency situation.
5. All persons must stay within the designated boundaries of the Super Saturdays Melbourne Market at all times.
6. The MMA reserves the right to refuse the admission of any person to the Market and may remove any person from the Market where deemed necessary, including for non-compliance of these Conditions.
7. The MMA reserves the right to temporarily restrict entry to manage crowd capacity and safety.
8. Any person entering the Market may be subject to filming or audio recording by closed circuit television, or other surveillance equipment within and surrounding the Market for operational security and public risk reasons and the MMA reserves the right to use such evidence in any dispute.
9. Any photography or cinematography captured by the MMA is the property of the MMA and may be used for marketing and promotional purposes.
10. Animals are not permitted except for certified assistance or service animals that are clearly identifiable to the public.
11. Unauthorised leafletting, fundraising, selling, or promotional activities are prohibited.
12. Any person found bringing weapons into the Market, spitting, using bad language, engaging in anti-social behaviour, loitering, or causing disruption to other customers will be required to leave the Market, and may be banned from the Market for any period determined by the MMA in the MMA's absolute discretion.
13. Footwear and shirts or other appropriate attire must be worn at all times in or about the Market. Clothing displaying offensive wording is prohibited.
14. For safety reasons, certain behaviours such as running, skateboarding, rollerblading, or cycling inside the Market are not permitted. Mobility scooters used to assist mobility impaired persons are allowed provided they are used at all times in a safe manner.
15. The consumption of alcohol and the use of illegal drugs in the Market is strictly prohibited. Any person whom the MMA suspects to be affected by or under the influence of alcohol or drugs may, in the MMA's sole discretion, be refused admission to or removed from the Market.
16. Smoking or vaping is only permitted in designated areas. Smoking or vaping in any other part of the Market (including but not limited to car parks) is strictly prohibited.
17. Any use of trolleys is at the user's own risk. The MMA accepts no responsibility or liability for any loss, damage, injury, or incident arising from the use of trolleys.
18. The MMA and the Market are not liable for any loss, theft, or damage to personal property.
19. Entry is at your own risk. To the full extent permitted by law, each person releases and indemnifies the MMA from all actions and demands due to any loss, death, damage or injury to any property or person occurring in the Market other than to the extent such loss, death, damage or injury is caused by negligence of the MMA, or its employees, servants and agents.
20. Persons must not damage, deface, misuse, interfere with, or tamper with any property, fixtures, fittings, equipment, infrastructure, or facilities located on or forming part of the Market.
21. Any person who damages or causes any damage or loss to any other person, property or goods at the Market will be liable for all direct, consequential or special loss or damage or injury suffered, and indemnifies and shall keep indemnified the MMA against all claims, expenses and

other liabilities which may be brought against or incurred by the MMA in relation to such loss and damage.

22. Commercial photography, filming, or media recording requires prior written approval from the MMA. Casual personal photography is permitted provided it does not inconvenience others.
23. Persons parking vehicles in the Market do so at their own risk. The MMA is not liable for any damage to vehicles, theft of any valuables from a vehicle or for any other loss or damage of whatever nature to any vehicle or to the contents of any vehicle parked or driven in the Market.
24. The MMA may collect personal information about any person entering the Market in order to operate the Market, to manage operations at the Market, to provide people with services, features and functions related to their use of the Market, and for purposes set out in the MMA's Privacy Policy.
